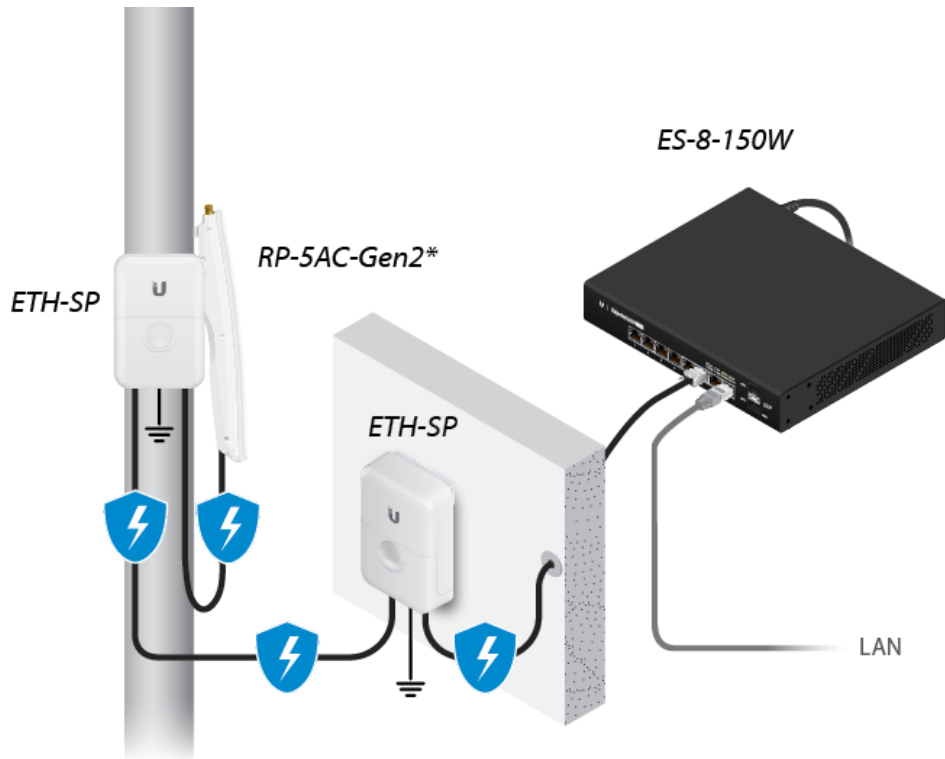

Installation Requirements

- The GPS Antenna needs to have clear line of sight to the sky for proper GPS operation.
- Shielded Category 5 (or above) cabling with drain wire should be used for all wired Ethernet connections and should be grounded through the AC ground of the PoE. We recommend that you protect your networks from harmful outdoor environments and destructive ESD events with industrial-grade, shielded Ethernet cable from Ubiquiti. For more details, visit ui.com/toughcable
- Surge protection should be used for all outdoor installations. We recommend that you use two Ethernet Surge Protectors, model ETH-SP, one near the RocketPrism and the other at the entry point to the building. The ETH-SP will absorb power surges and safely discharge them into the ground.



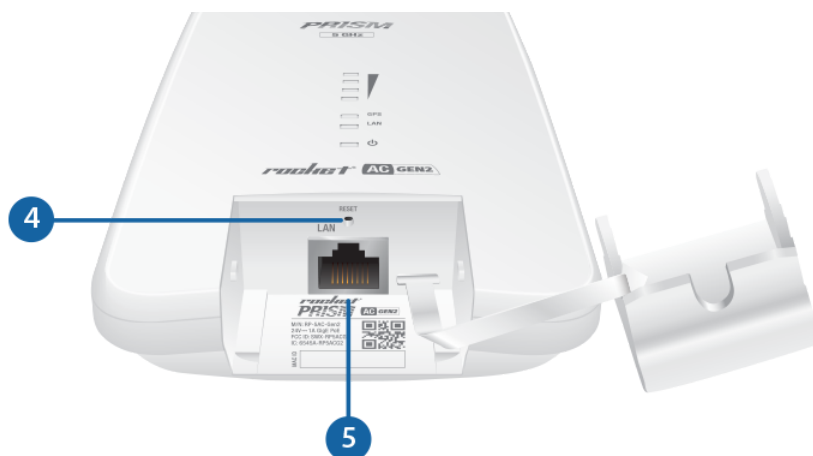

1 RP-SMA Antenna Connectors

Used to attach RF cables (not included).

2 GPS Antenna Connector

Used to attach the GPS Antenna.

3 LEDs

Signal In airOS®, you can modify the wireless signal strength threshold values for each LED on the Wireless tab under Signal LED Thresholds. Each LED will light when the wireless signal strength is equal to or greater than the LED's threshold value. The default values are shown below:

-65 dBm	
-73 dBm	
-80 dBm	
-94 dBm	

GPS The GPS LED will light steady blue when the GPS signal strength is sufficient. This requires a minimum of three satellite connections.

LAN The LAN LED will light steady blue when an active Ethernet connection is made to the LAN port and flash when there is activity.

Power The Power LED will light blue when the device is connected to a power source.

4 Reset Button

To reset to factory defaults, press and hold the Reset button for more than 10 seconds while the device is already powered on. Alternatively, the device may be reset remotely via a Reset button located on the bottom of the Gigabit PoE adapter.



The Gigabit Ethernet port is used to connect the power and should be connected to the LAN and DHCP server.

Hardware Installation

The Rocket is designed to mount directly onto a Ubiquiti airMAX RocketDish™ antenna for Point-to-Point use or an airMAX Sector antenna for Point-to-MultiPoint use.

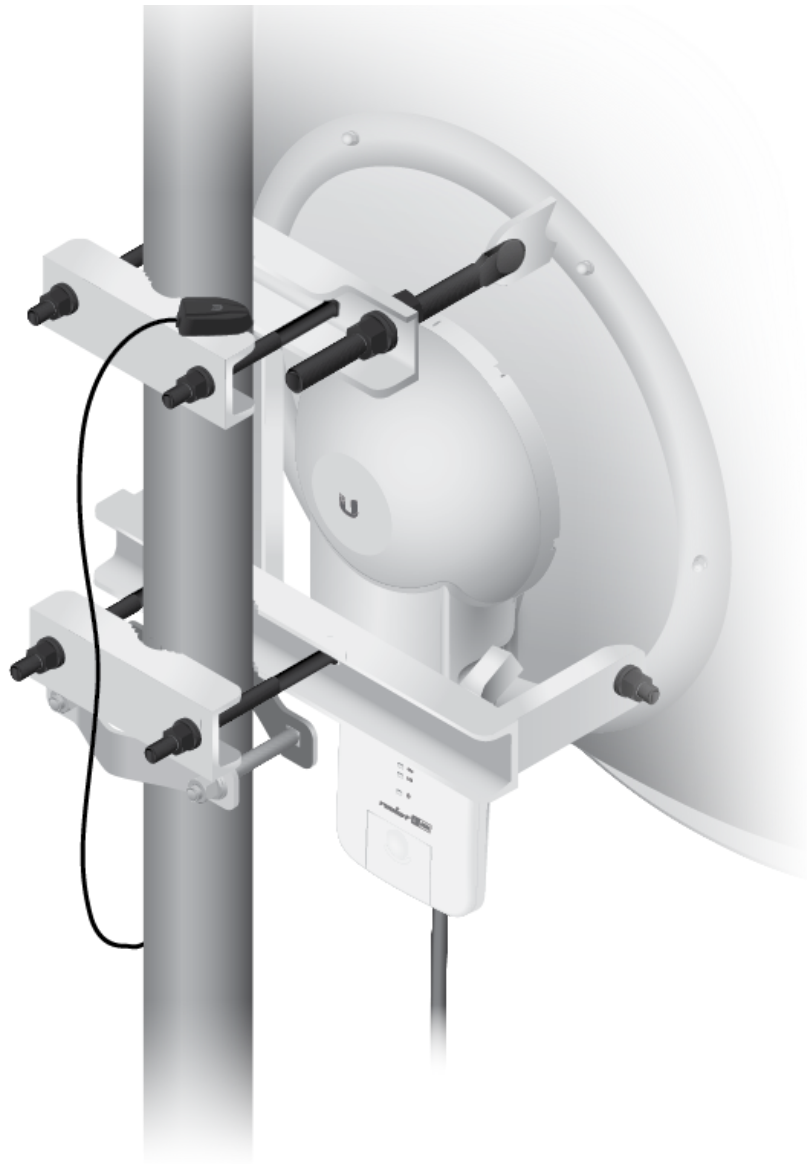

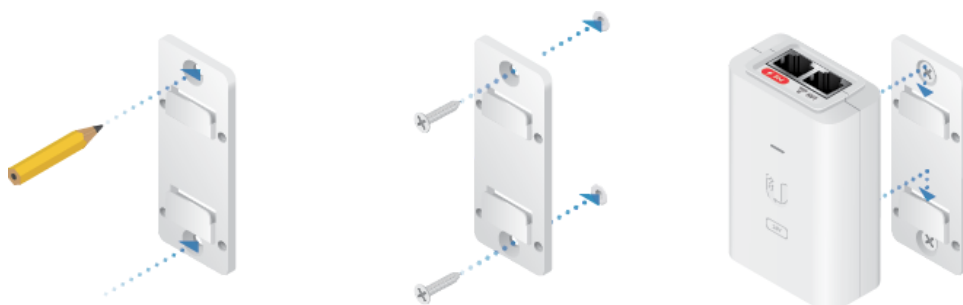
Connecting to the PoE Adapter

1. Connect the Ethernet cable from the device to the POE port of the PoE adapter.
2. Connect an Ethernet cable from your LAN to the LAN port of the PoE adapter.
3. Connect the Power Cord to the adapter, and then plug the Power Cord into a power outlet.



Mounting the PoE Adapter (Optional)

1. Remove the PoE Mounting Bracket from the adapter, place the bracket at the desired location, and mark the two holes.
2. Pre-drill the holes if necessary, and secure the bracket using two fasteners (not included).
3. Align the adapter's slots with the tabs of the PoE Mounting Bracket, and then slide the adapter down.



Accessing airOS via Wi-Fi

Verify connectivity in the airOS® Configuration Interface using the UISP™ app or Web Portal. Both are available for 15 minutes immediately after you power on the device. If necessary, you can power cycle the device to re-enable its Wi-Fi.

UISP App

1. Download the UISP app.



2. Connect your device's Wi-Fi to the SSID named: <model>:<MAC Address>



Note: Ensure that DHCP is enabled on your Wi-Fi adapter.

3. Launch the app and follow the on-screen instructions.

Antenna

Select your antenna from the list. If Calculate EIRP Limit is enabled, transmit output power is automatically adjusted to comply with the regulations of the applicable country. For a Custom antenna, Antenna Gain is entered manually. Note the requirements and antenna types listed below.

Cable Loss (When applicable)

Enter the cable loss in dB. Output power is adjusted to compensate for loss between the radio and the antenna.
